| Why?  | Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.                     |
| What? | The types of personal information we collect and share depend on the product or service you have with us. This information can include: <ul style="list-style-type: none"> <li>• Social Security number and Income</li> <li>• Account Balances and Account Transactions</li> <li>• Transaction History and Risk Tolerance</li> </ul> |
| How?  | All financial companies need to share members' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their members' personal information; the reasons Kinecta Federal Credit Union chooses to share; and whether you can limit this sharing.                  |

| How does Kinecta Federal Credit Union protect my personal information?   | To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.   |
| How does Kinecta Federal Credit Union collect my personal information?   | <p>We collect your personal information, for example, when you</p> <ul style="list-style-type: none"> <li>• open an account or deposit money</li> <li>• pay your bills or apply for a loan</li> <li>• seek advice about your investments</li> </ul> <p>We also collect your personal information from others, such as credit bureaus, affiliates, or other companies.</p>   |
| Why can't I limit all sharing?   | <p>Federal law gives you the right to limit only</p> <ul style="list-style-type: none"> <li>• sharing for affiliates' everyday business purposes-information about your creditworthiness</li> <li>• affiliates from using your information to market to you</li> <li>• sharing for non-affiliates to market to you</li> </ul> <p>State laws and individual companies may give you additional rights to limit sharing. See below for more on your rights under state law.</p>  |
| What happens when I limit sharing for an account I hold jointly with someone else?   | Your choices will apply to everyone on your account.  |

| Affiliates   | <p>Companies related by common ownership or control. They can be financial and non-financial companies.</p> <ul style="list-style-type: none"> <li>• <i>Our affiliates include:</i> <ul style="list-style-type: none"> <li>• <i>Companies with Kinecta in the name</i></li> <li>• <i>Financial Companies such as: Kinecta Alternative Financial Solutions, Kinecta Financial &amp; Insurance Services, Kinecta Financial Management Company</i></li> <li>• <i>non-financial companies such as Apollo Insurance Services</i></li> <li>• <i>and others, such as Nix Check Cashing, Nix Financial</i></li> </ul> </li> </ul> |
| Non-Affiliates   | <p>Companies not related by common ownership or control. They can be financial and non-financial companies.</p> <ul style="list-style-type: none"> <li>• <i>Kinecta does not share with non-affiliated third parties so they can market to you</i></li> </ul>   |
| Joint marketing  | <p>A formal agreement between non-affiliated financial companies that together market financial products or services to you.</p> <ul style="list-style-type: none"> <li>• <i>Our joint marketing partners include credit card companies, ID theft solution companies, mortgage companies, insurance companies.</i></li> </ul>   |

| <p>Kinecta is required to send this notice to our members annually. Once you opt out, you will remain opted out and do not need to do so again. If at any time you wish to change your opt out status, please contact us. State laws may give you additional rights to limit non-affiliate sharing.
